Mandeville, LA – St. Tammany Corporation has received two 2024 Excellence in Economic Development Awards from the International Economic Development Council (IEDC). The awards will be acknowledged and honored at the IEDC 2024 Annual Conference in Denver, CO, September 15-18.

St. Tammany Corporation was honored with the following awards for Economic Excellence:

- **GOLD**: NSpire Startup Slam Pitch Competition Special Event (Population 200,000 to 500,000)
- **BRONZE**: St. Tammany Corporation Economic Development Organization (EDO) of the Year (Population 200,000 to 500,000)

In November 2023, STartUP Northshore announced that *Kinkz*, a natural hair care line based in Slidell, Louisiana, was the winner of a \$60,000 prize package of cash and services following the live showdown between the company and three other finalists in the first-ever NSpire Startup Slam pitch competition. This award-winning pitch competition represents STartUP Northshore's investment in building programs that support local entrepreneurs and cultivate the regional entrepreneurial ecosystem by delivering world-class programming, networking opportunities, access to capital, and mentorship from esteemed industry leaders, investors, and founders at little to no cost to the startups. The NSpire Startup Slam is coordinated and directed by St. Tammany Corporation's STartUP Northshore Entrepreneur in Residence and Program Manager Vincenzo Caronna.
